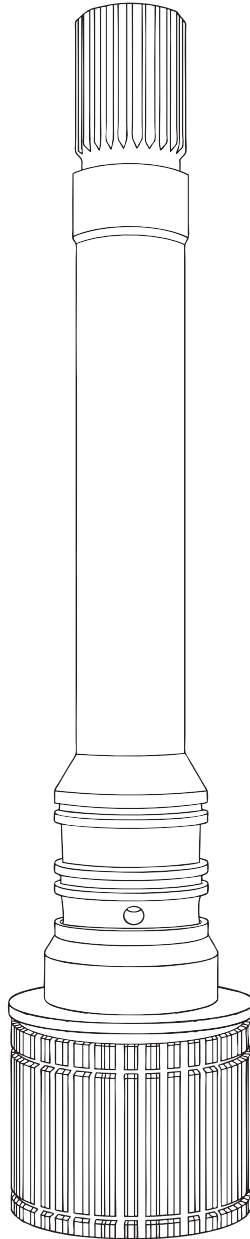

## **Billet Input Shaft**

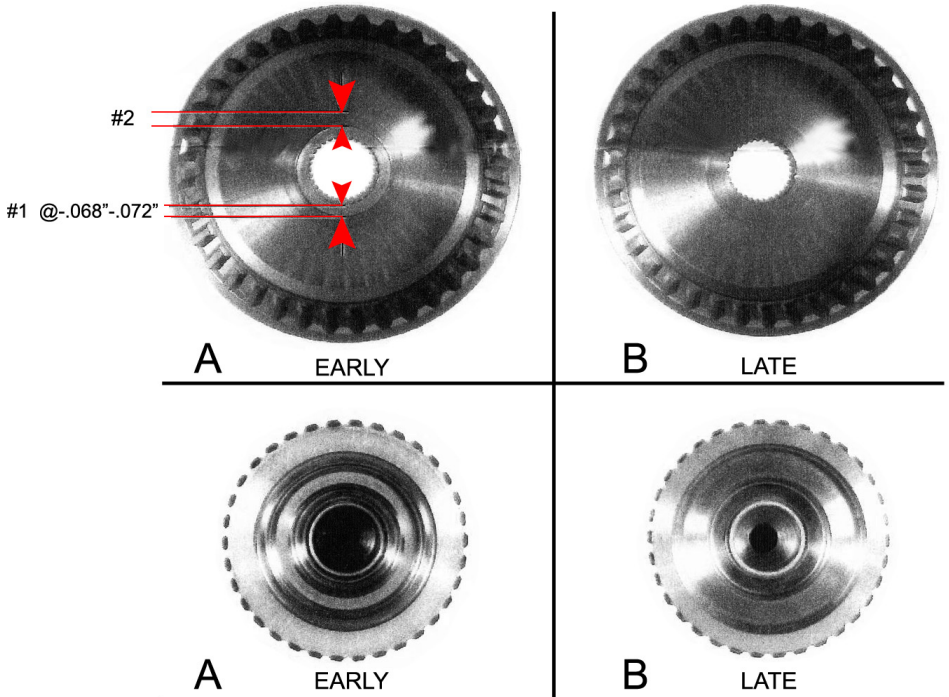

### Retrofit Allison Input Shaft to 2001-04 Transmission

From 2001-07 Allison used two different input shaft thrust bearings, one small bearing fitting the early @ 2001-04 shaft (marked "A") and a large bearing for the late 2004-07 shaft (marked "B") (SEE PHOTO BELOW)

The shaft uses the large late model bearing which can be retro fitted to the early transmission by machining the clutch hub. The early hub (marked "A") has a raised thrust flange (marked #1) that must be machined flush to the stepped flange (marked #2), by removing @ .068" - .072". The early hub will then be the same as the late model hub (marked "B") (SEE PHOTO BELOW)
